

Privacy Policy for ShiftyBocks

Introduction

This Privacy Policy describes how Engagepool ("we," "us," or "our") collects, uses, and discloses your information when you use our free slider puzzle game, ShiftyBlocks (the "Service").

Information We Collect

We collect the following information when you use the Service:

- **Non-Personal Information:** We collect non-personal information that does not identify you individually. This information may include your device type, operating system, language, and gameplay data (e.g., time spent playing, levels completed). We collect this information through analytics tools to understand how users interact with the Service and improve our offering.
